### RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT

I realize that fitness activities (basketball, volleyball, weightlifting, etc.) are vigorous physical activities. There are risks of injuries from the activities involved which include, but are not limited to, heat exhaustion, pulled or strained muscles, broken or crushed bones, damage to internal organs, permanent paralysis, and death. I understand that HILLCREST BAPTIST CHURCH has adopted particular rules for the use of the equipment, and for personal discipline and other precautions, but the risk of serious injury still exists, and I understand and accept and assume sole responsibility for said risks.

In order to properly protect my own safety, I agree to follow the safety rules. Further, in recognition of the importance of shared responsibility for safety, I agree to immediately report to the HILLCREST staff any noted deviations from the safety rules as well as any observed hazardous conditions or equipment.

I further certify that my present level of physical condition allows me to participate in using the fitness facility.
